Sub : Establishment of a Degree College at Chanchal.

Sir,

With reference to your letter No. 1358 dated 13.11.1968 and to our telegram dated 23.7. '69, I have to state that the Executive Council at its meeting held on 23rd July 1969 decided to grant temporary affiliation for one year to Chanchal College for the session 1969-70 in the following Courses and in the subjects shown against each :

- a) P.U. Arts - 1. English, 2. Bengali, 3. Civics & Economics, 4. History, 5. Arabic and 6. Sanskrit.
- b) Three Year Degree Arts - 1. English, 2. Bengali, 3. Economics, 4. Political Science, 5. History, 6. Arabic and 7. Sanskrit.

The affiliation now granted is subject to fulfilment of the following conditions

1. That the authority must place in Fixed Deposit with the State Bank of India a sum of net less than Rs. 50,000/- in the name of District Magistrate, Malda immediate
2. That the authority should deposit another sum of Rs. 50,000/- on the current account with the Bank in the name of the College as the working fund.
3. That the College must appoint a highly qualified and experienced Principal and shall pay him salary in the University Grants Commission Scale of pay.
4. That the College shall recruit duly qualified teachers with the concurrence of the University so as to ensure quality teaching and the teachers shall be paid salary in the University Grants Commission Scale of pay.
- ✓ 5. That the College Governing body must be reconstituted as per rule of the University (copy enclosed).
6. That books worth Rs. 7000/- shall have to be purchased for the College Library during the current academic session.
7. That the College authority shall have to purchase suitable land measuring 25 bighas (for College Building, Hostel Building, Teachers and Staff Quarters, Play-ground etc.) within the year 1970-71.
8. That the College authority shall have to provide suitable furniture and teaching materials and all other student amenities as recommended by the University Grants Commission.
9. That the College shall move to its own premises within the expiry of present term of permission from the Higher Secondary Board, West Bengal i.e. within 1971-72.
